**Please Read the Rules and Regulations for
A Country Christmas December 7th, 2019**

Please read & sign the application page & keep the rules/regulation for your reference.

1. Applications and payment must be received no later than December 3rd, 2019. Any application received later than December 3rd, 2019 will be assessed a late fee of \$25.00 per booth space and must be included with your application. Please see application page for fees and deadlines..
2. A Country Christmas hours are: Saturday 4:30 p.m – 7:30 p.m. The festival will take place rain or shine. Set up begins at 3 pm.
3. There will be no booth refunds after December 3rd, 2019.
4. No exhibitor shall assign, sublet or apportion any part of their space without prior written approval from A Country Christmas Committee.
 - a. Vendors can only sell items that have been approved in their application submitted to A Country Christmas Committee. Please fill out the description on the application. A Country Christmas wants to limit excessive duplication of festival items and ensure proper spacing of similar items at the festival.
5. **NO LATE OPENINGS, NO EARLY CLOSING, NO EARLY BREAKDOWN. NO EXCEPTIONS.** Anyone not complying with this rule will not be allowed to return next year.
6. Vendor personnel must manage the booths during the operating hours of A Country Christmas.
7. Neither A Country Christmas Committee nor the City of Williamstown is responsible for any loss or damage incurred to the exhibitors' property. The exhibitor also agrees to hold harmless and indemnify A Country Christmas Committee or the City of Williamstown, KY against any claims arising by virtue of their occupancy of the premises or use thereof.
8. Please decorate your booth appropriately. Tables must be draped.
9. No radios or loud speakers are allowed in booths.
10. Vehicles belonging to craft or food vendors are not allowed into the festival during working festival hours. **NO EXCEPTIONS.** Vendors will be allowed to enter the festival area before and

after festival hours to set up and tear down booths. Vehicles must be removed prior to start of the festival.

11. No election campaigning from any booth.
12. Exhibitors are responsible for the collection of Kentucky Sales Tax.
13. No food or drink can be sold from any booth except at designated food booths without written permission from the Festival Committee and proper Department of Health licensing.
14. No drilling or defacing the streets or sidewalks by anchors will be permitted.
15. If your booth has an activity or project that creates litter, please be considerate and clean it up during and after the festival. Please minimize the volume of trash to be disposed at a Country Christmas by breaking down any cardboard boxes. A Country Christmas will provide receptacles for trash and will locate dumpsters near the festival. Help us keep the streets clean.
